PART I. GENERAL EXPECTATIONS

These meetings will include a description and explanation of curriculum materials that are to be ordered.

The Manchester Local School District will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

The Manchester Local School District will take the following actions to provide each parent timely notice: when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

Manchester Local School District will send out letter notifications to parents should the aforementioned occur.

- 8. The Manchester Local School District will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

Manchester Local School District will provide assistance to parents by scheduling meetings as requested. Information may also be disseminated at Parent/Teacher Conferences, Open House, or other scheduled meetings throughout the school year. Manchester Local School District may provide resources and information to parents via State & Federal Programs websites, printed materials, as well as researching classes and workshops for parents to attend.

9. The Manchester Local School District will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

The teachers of Manchester Local School District will work collaboratively with parents throughout the school year to provide necessary materials and tips they may utilize to assist their child to achieve his or her highest academic potential.
