#### **SCHOOL-PARENT COMPACT**

##### School Responsibilities

The Manchester Local School District will:

**Progress reports will be sent home to parents at the mid-term of a quarterly period with report cards sent at the end of the quarter.**

**Parents are always welcome to volunteer. They must meet with the building principal, complete necessary paperwork, background check, and be approved by the Board of Education during a formal Board Meeting. Parents may observe/participate in their child's classroom by scheduling their visit with the principal and teacher.**
